1) Financial

• Tracey shared that she has requested the state for modification on the grant we have through OCFS. We would like to keep it open-ended as we aren't sure what exactly the mental health campaign will look like that we will be launching in the near future.

2) Discussion:

- It was noted that youth are really struggling and need support as isolation. Those that were struggling before are now falling under the radar as schools and outside prosocial groups don't have as much access to them.
- It's important to remember the impact COVID has had on everyone teachers, students, etc. Whatever our campaign will be should be inclusive to all and a positive message to help people cope. People are tired and many miss the energy that comes with being with people.
- Bloomfield has tapped their "Sources of Strength" and Youth Mental Health First Aid to bring youth into the conversation about mental health.
- Conversation about businesses and the fact that many of them are undercapitalized. Many of the small businesses, the owners find themselves the operators which is difficult to sustain. Those business challenges have affected the workers also (unemployment).
- Are we missing those that are high functioning and hide their hurt? With our campaign, is there a way to quietly remind folks that there are choices always?
- There has been an increase in sexual abuse with 6-10 year old children. Online bullying has increased as well.
- Erin L noted that Family Counseling Services of the Finger Lakes is going to be offering a "seeking safety" online group for young girls.

- Interns Lisa and Mackenzie noted that they will be doing more on social media (FB and IG) and encouraged the group to follow/like/repost.
- Tracey walked through the EmpowerOC.org website. An online repository of information and resources. Please let Tracey know if there needs to be something added to the resource list on the website.
- The question was posed are we LISTENING to people? Take the time to listen.
